Make the Money, Pay the Tax

If it moves... tax it, if it doesn't move, tax it until it does. We often get asked,

(A) "If I invest in will I pay tax on it?" Broadly speaking if you, invest in / buy something with a view to make money on it, any profit you make may become taxable.

This is true for - Property

- Precious metals
- Crypto currencies
- Foreign currencies
- Vehicles, boats, planes

Particularly if there is no ability to earn an income from the investment. This is exactly the case for investments in gold.

But don't be put off by this, if you believe in it as an investment and you can see an opportunity to make a dollar, make the money (profit), pay the tax, the rest is yours to keep to reinvest or spend.

(B) The same goes for spending money. "If I buy..... will it reduce my tax?" There is little point in spending \$1.00 to save 0.33/0.39 cents.

Spend the money on things that are going to make life or business easier or increase efficiencies or make more money. The Reserve Bank lowered the Official Cash Rate (OCR) by 25 basis points to 3% on 20 August



2025, a three year low. Good news for mortgage rates as these will generally trend downward with some banks having already adjusted their rates



Fonterra's Recent Forecast Announcements

On 20 August 2025, Fonterra lifted its 2024/25 forecast Farmgate milk price by 15 cents to \$10.15 per kgMS and narrowed the range from \$9.70 - \$10.30 per kgMS to \$10.10 - \$10.20 per kgMS. For the 2025/26 season it narrowed its forecast range to \$9.00 - \$11.00 per kgMS.

Bank Surcharge Proposals - What's Brewing?



In July 2025 the government announced plans to ban most in store surcharges on debit (EFTPOS, domestic Visa, Mastercard) and credit card payments. The ban is expected to take effect by May 2026 at the latest and would eliminate those surprise charges at the till, whether you are tapping, swiping or using a digital wallet. Whilst this is good news for consumers, it could mean higher underlying costs for small businesses, as without the option to add a surcharge many operators may be forced to absorb these costs or increase prices to maintain margins.

Paid Parental Leave Rate Change

From 1 July 2025, eligible employees and selfemployed people will see an increase in the parental leave payment from \$754.87 to \$788.66 each week before tax.

To switch to SMS notifications, follow these steps in myIR.

How is KiwiSaver Changing?

- * Increase the default employer and employee KiwiSaver contribution rates from 3% to 3.5% from 1 April 2026, and then to 4% from 1 April 2028.
- * Allow members to choose to temporarily remain at the current 3% and still be matched at that rate by their employer.
- * Extend KiwiSaver eligibility to 16–17 year-olds, allowing them to access both employer and Government contributions.
- * Reduce the government contribution rate from 50 cents for each dollar member contributes to 25 cents from 1 July 2025. The maximum government contribution will reduce from \$521.43 to \$260.72 per year.
- *Limit eligibility for the annual Government contribution to those earning \$180,000 or less.

Are you Eligible to get a Rates Rebate?

What it is:

A government subsidy for low-income homeowners to help pay their council rates.



Maximum amount:

The highest possible rebate for the 2025/26 financial year is \$805.

Eligibility criteria:

- You must be a homeowner.
- You must have a low household income for the period 1 April 2024 to 31 March 2025.
 The maximum income for a standard applicant is \$32,210.
- SuperGold cardholders have a higher income threshold to receive the maximum rebate, up to \$45,000.

You can download and print an application form from the New Zealand Government website or pick up a printed copy from your local council.

With MyACC for Business you can:

- Check your balance and pay your invoice by direct debit or credit card;
- Access your activity timeline to view transaction history and download invoices, so you no longer need to maintain paper copies;
- Keep your contact and business details up to date, including change of bank account numbers;
- Spread your payments out by setting up direct debit instalments over three or six months.
